Directions to Site: From 15 South or North exit on Clinton Keith and go west 3.9 miles to the 3-way STOP sign at the top of the hill. Turn right on Avenue La Cresta and travel 3.9 miles to Calle de Companero. Turn right about .2 miles and take the first left on Vista de Montana. From there it is 1 mile to the T intersection at the bottom of the canyon. Turn right on Via Sereno and the ranch entrance is .2 miles on your right just after the creek crossing.

Our Trial Committee consider disciplinary action for any complaints lodged against an Exhibitor. Do not allow your dog(s) to destroy property or disturb other guests. ***Please***, pick up after your dog both at the hotel and the trial site.

Hotel and RV camping

We are located within 20 minutes of the Temecula Wine Country. There are several hotels in the area such as South Coast Winery Resort and Spa. Temecula has several hotels that allow pets at a wide range of prices La Quinta Inn & Suites, Motel 6 are the most reasonable and are pet friendly.

We have a few dry camping spots available on site at \$15 per night. There are limited 20A electric & water hookups available at \$25/night. Please call Kathy Greenway at 574-344-1889 to make RV spot arrangements. Vail Ranch KOA on CA-79 is a full hook-up campground.

CLASS INFORMATION

Standard Classes (for reference as to what FUN RUN level to enter)

Beginner Agility – A beginner class which includes teeter, dog walk and A-Frame but no weaves.

Intermediate Agility – This class adds 6 weave poles to the course and more obstacles.

Superior Agility – This class has 12 poles, and is the highest TDAA class.

Games Classes

1st Game: VOLCANO

Numbered course where handler must not stop, go back to correct a missed obstacle, or allow the dog to cross over their own path. 1 point earned for each obstacle performed. Scored points, then time. ER2

2nd Game: SUMMER DANCE PARTY

Numbered course with dance floor for a short Dance Party with your dog. Scored faults then time. ER12

3rd Game: TOUCH AND GO

Numbered course consisting of contact obstacles and tunnels only. Scored faults then time. ER12

4th Game: MUTE AGILITY

Numbered course where handler must run entire course silently. Body language must speak for itself. Scored faults then time. ER12.

5th Game: JACKPOT

Point accumulation game with one or more distance challenges. Scored points then time. ER4

The judge will give a detailed briefing of each game's rules prior to running the course.

NOTICE TO EXHIBITORS

Obstacle Familiarization – Obstacle familiarization will be held after the briefing prior to judging.

Warm-Ups – A warm-up area consisting of a regulation agility jump shall be provided for all Exhibitors to share.

Show Site – The arena is fenced and has groomed level ground. All contacts have a rubberized surface. There is parking and set up around the arena with short walking distance to the gates. There is a restroom with running water and a flush toilet.

Judging Times: Event starts at **8:00 a.m.** • Site will open at 6:30 a.m. • Briefings: 7:00 to 7:30 a.m. R.V. parking by appointment booked with Kathy Greenway at 574-344-1889.

The event uses standard full sized NADAC/CPE/AKC equipment. (A Frame is set at 5' Apex)

Agreement (Include with your entry form)

I/We agree that 2K Agility has the right to refuse entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Agility Fun Run I/We agree to hold harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or things by the act of this dog while in or upon the show/trial premises or grounds or near any entrance thereto. I/We personally assume all responsibility and liability for any such claim, and I/We further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the organizer or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I/We hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time arising out of or in consequence of my/our participation in this Agility Fun Run, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.
